- 2. The Front Desk Staff CANNOT ANSWER QUESTIONS FOR YOU. They can only provide you with the form.
- 3. The Legal Department MUST review and approve any and all records requests because case file information is not a public record under Ohio law.
- 4. Please be aware that we process many records requests. These requests often require us to obtain files from storage and sort through the entire case file to find the requested document(s).

PLEASE BE AWARE THAT YOUR REQUEST COULD TAKE ANYWHERE FROM 14-30 DAYS TO COMPLETE.
